a. Committee approved the Minutes of the last meeting.

II. Budget Report

a. Following the one-time approval for FY18 supplemental funding for Title IX and Financial Aid, the balance for FY18 available funds is reflected in the budget report.

III. New Business

- a. The committee considered the following FY18 supplemental requests:
 - i. The Rec-Sports department requested funding for twenty new Spin Bikes.
 - ii. The Rec-Sports department requested funding for the repair of plumbing around the HPC pool and Spa.
 - iii. The Softball team requested funding for a new tarp to cover the softball field.
 - iv. The Campus Activities department asked for funding to help cover the cost of food for students at homecoming.
 - The Police department asked for funding to cover the costs of the on-campus safety and security smartphone application.
 - vi. The Student Publications department asked for funding of camera equipment.
 - vii. Student Life and Leadership asked for funding for a student engagement platform.
 - viii. The Athletics department requested partial funding for the renovation of the entrance to the PHE.
- b. The committee entertained conversation and made the following decisions on the requests made for funding:
 - i. The Rec-Sports department request for Spin Bikes was approved for \$24,817.55 by voice vote
 - ii. The Rec-Sports department request for Plumbing repair was approved for \$4,466.28 by voice vote
 - iii. The Softball Team request for a new tarp was approved for \$6142.44 by voice vote
 - iv. Campus Activities department request for food funding for homecoming was approved for \$3000 by voice vote
 - v. UT Police Department request for funding of the RAVE Guardian Student Smart Phone App. was approved for \$5000 by voice vote. SFAC requested UT PD engage in a campus-wide marketing plan to increase student subscription to the safety service.
 - vi. Student Publication request for funding of the camera equipment was denied by voice vote. It was related that Student Publications is a student organization and therefore entitled to request a per semester allotment from SGA.
